Summary

A passenger plane of a private airliner carrying 152 passengers crashed in a ball of flames here into densely wooded hills outside Islamabad leaving everyone on board dead.

Pieces of charred flesh and body parts were littered around the smouldering wreckage, partially buried on Margala hillside. The plane disintegrated into a gorge between two hills, enveloped in cloud and some distance from the road, severely hampering rescue efforts and limiting visibility.

Upon receiving the news, the Directorate General Civil Defence immediately mobilised its officers, instructors, trainees, and volunteers. All the available and necessary equipment like stretchers, blankets, and bags were dispatched to the place of accident. The chief wardens of Islamabad and Rawalpindi came with 50 volunteers each including 8 lady volunteers. Thirty two trainees at the National Institute of Fire Technology were also involved in the rescue and relief operation.

I personally supervised the entire operation of the civil defence volunteers. The volunteers were dispatched from the base line rescue crews and team as per the requirement and demand of the Pakistan Army officers stationed at the place of accident. These volunteers enthusiastically participated in the entire operation of gathering the dead bodies, body parts, and belongings of the passengers of the unfortunate plane. The civil defence officers and volunteers did not allow the paucity of material resources, equipment, and tools to hamper the rescue efforts.

I assure you Sir, that with your continued support and guidance our volunteers will continue to respond to any accident with the same zeal and enthusiasm.

I would like to request that certificates of appreciation be awarded to these volunteers who performed their duties selflessly and with a sense of sacrifice without any expectations of monetary and material gain.


Belongings of the deceased passengers

- II. One original CNIC of deceased passenger namely Idrees Ahmed S/o Haji Habib resident of Karachi.
- III. Wallet of deceased Mr. Asif Shehzad S/o Muhammad Anwar resident of Karachi. Containing VISA / ATM Cards.
- IV. Wallet of deceased Mr. Adnan Qayoom resident of Islamabad, containing Driving License, MCB Card and Rs. 23860/- in cash.
- V. The belongings of deceased passengers are being delivered.
